Companies on this list with one or more federally qualified long-term care policies or that offer long-term care partnership products are also identified. Premiums and/or benefits under Qualified Long-Term Care Policies may qualify for favorable tax treatment. If you have questions on how the purchase of a qualified long-term care policy will impact the taxes you pay, you should consult with your tax advisor
