

combined-cycle generating station as described in § 56-585.1 A 6 of the Code.¹¹ For purposes of calculating the Actual Cost True-Up Factor, the Company used an enhanced ROE of 11% for the months of January 2016 through August 2016; and an enhanced ROE of 10.6% for the months of September 2016 through December 2016, which comprises the general ROE of 10%¹² and 9.6%¹³ respectively, plus the 100 basis point enhanced return.¹⁴

If the proposed Rider BW for the 2018 Rate Year is approved, the impact on customer bills would depend on the customer's rate schedule and usage. According to Dominion Energy Virginia, implementation of its proposed Rider BW on September 1, 2018, would decrease the monthly bill of a residential customer using 1,000 kilowatt hours per month by approximately \$0.13.¹⁵

The Company indicates that it has calculated the proposed Rider BW rates in accordance with the same methodology as used for rates approved by the Commission in the most recent Rider BW proceeding, Case No. PUE-2016-00112.¹⁶

Dominion also requests a waiver of Rules 20 VAC 5-201-60 ("Rule 60") and 20 VAC 5-201-90 ("Rule 90") of the Rules Governing Utility Rate Applications and Annual

Informational Filings ("Rate Case Rules")¹⁷ with respect to Schedule 45. Rule 60 of the Rate Case Rules requires that an application filed pursuant to § 56-585.1 A 6 of the Code include Schedule 45, "Return on Equity Peer Group Benchmark," with the utility's direct testimony. Rule 90 of the Rate Case Rules states that Schedule 45 must include "documentation supporting the return on equity benchmark proposed pursuant to § 56-585.1 A 2 a and b of the Code" In support of its request for waiver of Schedule 45, Dominion states that it has requested in this Application that the general ROE of 10.5%, which the Company proposes in a separate proceeding for the determination of an ROE applicable to certain rate adjustment clauses in Case No. PUR-2017-00038,¹⁸ plus a 100 basis point enhanced return, be used to calculate the revenue requirement. The Company filed testimony and other evidence in support of its requested general ROE, including Filing Schedule 45 materials and analysis, in Case No. PUR-2017-00038 and states that the ROE determined in that case will apply to Rider BW for the 2018 Rate Year. Accordingly, the Company asserts that waiver of Schedule 45 in this proceeding is warranted by judicial economy and efficiency of case administration.¹⁹

Finally, in conjunction with the filing of its Application on October 3, 2017, the Company filed the "Motion of Virginia Electric and Power Company for Entry of a Protective Ruling" ("Motion for Protective Ruling") and a proposed protective ruling that establishes procedures governing the use of confidential information in this proceeding.

NOW THE COMMISSION, upon consideration of this matter, is of the opinion and finds that this matter should be docketed; Dominion Energy Virginia should provide public notice of

its Application; a public hearing should be scheduled for the purpose of receiving testimony and evidence on the Application; interested persons should have an opportunity to file comments on the Application or participate as a respondent in this proceeding; and the Commission's Staff ("Staff") should be directed to investigate the Application and file testimony and exhibits containing its findings and recommendations thereon.

We also find that a Hearing Examiner should be assigned to conduct all further proceedings in this matter on behalf of the Commission, including ruling on the Company's Motion for Protective Ruling, and filing a final report containing the Hearing Examiner's findings and recommendations.

Finally, we grant the Company's request to waive the filing of Schedule 45 for purposes of making this Application complete and commencing this proceeding.

Accordingly, IT IS ORDERED THAT:

(1) This matter is docketed and assigned Case No. PUR-2017-00128.

(2) As provided by § 12.1-31 of the Code and Rule 5 VAC 5-20-120, *Procedure before Hearing Examiners*, of the Commission's Rules of Practice and Procedure ("Rules of Practice"),²⁰ a Hearing Examiner is appointed to conduct, on behalf of the Commission, all further proceedings in this matter, including ruling on any discovery issues and the Company's Motion for Protective Ruling, and filing a final report containing the Hearing Examiner's findings and recommendations.

(3) A public hearing on the Company's Application shall be convened on March 29, 2018, at 10 a.m., in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, to receive the testimony of public witnesses

On October 3, 2017, Virginia Electric and Power Company ("Dominion Energy Virginia" or "Company"), pursuant to § 56-585.1 A 6 of the Code of Virginia, filed with the State Corporation Commission ("Commission") an annual update with respect to the Company's rate adjustment clause, Rider BW ("Application"). Through its Application, the Company seeks to recover costs associated with the Brunswick County Power Station ("Brunswick County Power Station" or "Project"), a 1,358 megawatt nominal natural gas-fired combined-cycle electric generating plant and associated transmission facilities located in Brunswick County, Virginia.

In Case No. PUE-2012-00128, the Commission approved the development of the Brunswick County Power Station. In conjunction therewith, the Commission also approved a rate adjustment clause, designated Rider BW, which allowed Dominion Energy Virginia to recover costs associated with the development of the Project, including projected construction work in progress and any associated allowance for funds used during construction. According to Dominion Energy Virginia, the Brunswick County Power Station commenced commercial operations on April 25, 2016.

In this proceeding, Dominion Energy Virginia has asked the Commission to approve Rider BW for the rate year beginning September 1, 2018, and ending August 31, 2019 ("2018 Rate Year"). The Company is requesting a total revenue requirement of \$132,391,000 for the 2018 Rate Year. Dominion Energy Virginia proposes to use enhanced rates of return on common equity of 11.5%, 11%, and 10.6% for purposes of calculating the Rider BW revenue requirement.

If the proposed Rider BW for the 2018 Rate Year is approved, the impact on customer bills would depend on the customer's rate schedule and usage.

Interested persons are encouraged to review the Application and supporting documents for the details of these and other proposals.

TAKE NOTICE that the Commission may apportion revenues among customer classes and/or design rates in a manner differing from that shown in the Application and supporting documents and thus may adopt rates that differ from those appearing in the Company's Application and supporting documents.

The Commission entered an Order for Notice and Hearing that, among other things, scheduled a public hearing on March 29, 2018, at 10 a.m., in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, to receive testimony from members of the public and evidence related to the Application from the Company, any respondents, and the Commission's Staff. Any person desiring to testify as a public witness at this hearing should appear in the Commission's courtroom fifteen (15) minutes prior to the starting time of the hearing and contact the Commission's Bailiff.

The public version of the Company's Application, as well as the Commission's Order for Notice and Hearing, are available for public inspection during regular business hours at each of the Company's business offices in the Commonwealth of Virginia. Copies also may be obtained by submitting a written request to counsel for the Company, Lisa S. Booth, Esquire, Dominion Energy Services, Inc., 120 Tredegar Street, Richmond, Virginia 23219. If acceptable to the requesting party, the Company may provide the documents by electronic means.
