ORDER FOR NOTICE AND HEARING

On October 3, 2018, Virginia Electric and Power Company d/b/a Dominion Energy Virginia ("Dominion" or "Company"), pursuant to § 56-585.1 A 6 of the Code of Virginia ("Code"), filed with the State Corporation Commission ("Commission") an annual update with respect to the Company's rate adjustment clause, Rider US-2 ("Application"). Through its Application, the Company seeks to recover costs associated with (i) the Scott Solar Facility, a 17 megawatt ("MW") (nominal alternating current ("AC")) facility located in Powhatan County; (ii) Whitehouse Solar Facility, a 20 MW AC facility located in Louisa County; and (iii) Woodland Solar Facility, a 19 MW AC facility located in Isle of Wight County (collectively, "2016 Solar Projects" or "Projects").<sup>1</sup>

In Case No. PUE-2015-00104,<sup>2</sup> the Commission approved construction of the 2016 Solar Projects. In conjunction therewith, the Commission also approved a rate adjustment clause, designated Rider US-2, which allowed Dominion to recover costs associated with the

development of the Projects, including projected construction work in progress and any associated allowance for funds used during construction.<sup>3</sup>

In this proceeding, Dominion has asked the Commission to approve Rider US-2 for the rate year beginning September 1, 2019, and ending August 31, 2020 ("2019 Rate Year").<sup>4</sup> The two key components of the proposed total revenue requirement for the 2019 Rate Year are the Projected Cost Recovery Factor and the Actual Cost True-Up Factor.<sup>5</sup> The Company is requesting a Projected Cost Recovery Factor revenue requirement of \$9,212,151 and an Actual Cost True-Up Factor revenue requirement of \$7,039,346.<sup>6</sup> Thus, the Company is requesting a total revenue requirement of \$16,251,497 for service rendered during the 2019 Rate Year.<sup>7</sup>

For purposes of calculating the Projected Cost Recovery Factor in this case, Dominion proposes a rate of return on common equity ("ROE") of 9.2%, which it states is supported by the Commission's Final Order in Case No. PUR-2017-00038.<sup>8</sup> For purposes of calculating the Actual Cost True-Up Factor, the Company utilized an ROE of 9.6% for the months of January 2017 through March 2017, which was approved by the Commission in its Final Order in Case No. PUE-2015-00104, an ROE of 9.4% for the period of April 1, 2017, through November 28,

2017, which was approved by the Commission in its Order in Case No. PUE-2016-00113,<sup>9</sup> and an ROE of 9.2% for the period of November 29, 2017, through December 31, 2017, which was approved by the Commission in its 2017 ROE Order.<sup>10</sup>

If the proposed Rider US-2 for the 2019 Rate Year is approved, the impact on customer bills would depend on the customer's rate schedule and usage. According to Dominion, implementation of its proposed Rider US-2 on September 1, 2019, would increase the monthly bill of a residential customer using 1,000 kilowatt hours per month by approximately \$0.07.<sup>11</sup>

The Company proposes a change in the methodology for the calculation of a certain allocation factor beginning in 2018 to recognize the output of certain non-utility generators to be used to allocate cost responsibility to the Virginia jurisdiction.<sup>12</sup> In addition, with the exception of the removal of certain Federal and retail choice customers from the Virginia jurisdiction, the Company indicates it has calculated the proposed Rider US-2 rates in accordance with the same methodology as used for rates approved by the Commission in the most recent Rider US-2 proceeding, Case No. PUR-2017-00127.<sup>13</sup>

Dominion also requests a waiver of Rules 20 VAC 5-201-60 ("Rule 60") and 20 VAC 5-201-90 ("Rule 90") of the Rules Governing Utility Rate Applications and Annual

Informational Filings ("Rate Case Rules") with respect to Schedule 45. Rule 60 of the Rate Case Rules requires that an application filed pursuant to Code § 56-585.1 A 6 include Schedule 45, "Return on Equity Peer Group Benchmark," with the utility's direct testimony. Rule 90 of the Rate Case Rules states that Schedule 45 must include "documentation supporting the return on equity benchmark proposed pursuant to § 56-585.1 A 2 a and b of the Code . . . ." In support of its request for waiver of Schedule 45, Dominion states that the Commission approved a 9.2% ROE in its 2017 ROE Order to be applied to Dominion's Subsection A 5 and A 6 rate adjustment clauses, including Rider US-2.<sup>14</sup> Dominion indicates that, in this proceeding, it is requesting that an ROE of 9.2% be used to calculate the Projected Cost Recovery Factor revenue requirement for Rider US-2. Accordingly, the Company asserts that waiver of this schedule in this proceeding is warranted by judicial economy and efficiency of case administration.<sup>15</sup>

Finally, in conjunction with the filing of its Application on October 3, 2018, the Company filed the Motion of Virginia Electric and Power Company for Entry of a Protective Ruling ("Motion for Protective Ruling") and a proposed protective ruling that establishes procedures governing the use of confidential information in this proceeding.

NOW THE COMMISSION, upon consideration of this matter, is of the opinion and finds that this matter should be docketed; Dominion should provide public notice of its Application; a public hearing should be scheduled for the purpose of receiving testimony and evidence on the Application; interested persons should have an opportunity to file comments on the Application or participate as a respondent in this proceeding; and the Commission's Staff ("Staff") should be

directed to investigate the Application and file testimony and exhibits containing its findings and recommendations thereon.

We also find that a Hearing Examiner should be assigned to conduct all further proceedings in this matter on behalf of the Commission, including ruling on the Company's Motion for Protective Ruling and filing a final report containing the Hearing Examiner's findings and recommendations.

Finally, we grant Dominion's request to waive the filing of Schedule 45 for purposes of making the Application complete and commencing this proceeding.

Accordingly, IT IS ORDERED THAT:

(1) This matter is docketed and assigned Case No. PUR-2018-00167.

(2) As provided by § 12.1-31 of the Code and Rule 5 VAC 5-20-120, *Procedure before Hearing Examiners*, of the Commission's Rules of Practice and Procedure ("Rules of Practice"),<sup>16</sup> a Hearing Examiner is appointed to conduct all further proceedings in this matter on behalf of the Commission.

(3) A public hearing on the Application shall be convened on March 19, 2019, at 10 a.m., in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, to receive the testimony of public witnesses and the evidence of the Company, any respondents, and the Staff. Any person desiring to offer testimony as a public witness at this hearing should appear in the Commission's courtroom fifteen (15) minutes prior to the starting time of the hearing and identify himself or herself to the Commission's Bailiff.

On October 3, 2018, Virginia Electric and Power Company d/b/a Dominion Energy Virginia ("Dominion" or "Company"), pursuant to § 56-585.1 A 6 of the Code of Virginia, filed with the State Corporation Commission ("Commission") an annual update with respect to the Company's rate adjustment clause, Rider US-2 ("Application"). Through its Application, the Company seeks to recover costs associated with (i) the Scott Solar Facility, a 17 megawatt ("MW") (nominal alternating current ("AC")) facility located in Powhatan County; (ii) Whitehouse Solar Facility, a 20 MW AC facility located in Louisa County; and (iii) Woodland Solar Facility, a 19 MW AC facility located in Isle of Wight County (collectively, "2016 Solar Projects" or "Projects").

In Case No. PUE-2015-00104, the Commission approved construction of the 2016 Solar Projects. In this proceeding, Dominion has asked the Commission to approve Rider US-2 for the rate year beginning September 1, 2019, and ending August 31, 2020 ("2019 Rate Year"). The two key components of the proposed total revenue requirement for the 2019 Rate Year are the Projected Cost Recovery Factor and the Actual Cost True-Up Factor. The Company is requesting a Projected Cost Recovery Factor revenue requirement of \$9,212,151 and an Actual Cost True-Up Factor revenue requirement of \$7,039,346. Thus, the Company is requesting a total revenue requirement of \$16,251,497 for service rendered during the 2019 Rate Year.

For purposes of calculating the Projected Cost Recovery Factor in this case, Dominion proposes a rate of return on common equity ("ROE") of 9.2%, which it states is supported by the Commission's Final Order in Case No. PUR-2017-00038. Any person desiring to testify as a public witness at this hearing should appear fifteen (15) minutes prior to the starting time of the hearing and contact the Commission's Bailiff.

Copies also may be obtained by submitting a written request to counsel for the Company, Lisa S. Booth, Esquire, Dominion Energy Services, Inc., 120 Tredegar Street, Richmond, Virginia 23219. If acceptable to the requesting party, the Company may provide the documents by electronic means.

On or before December 28, 2018, any person or entity wishing to participate as a respondent in this proceeding may do so by filing a notice of participation. A copy of the notice of participation as a respondent also must be sent to counsel for the Company at the address set forth above. Any organization, corporation, or government body participating as a respondent must be represented by counsel as required by Rule 5 VAC 5-20-30, *Counsel*, of the Rules of Practice. (11) On or before February 8, 2019, each respondent may file with the Clerk of the Commission at the address set forth in Ordering Paragraph (7) and serve on the Staff, the Company, and all other respondents, any testimony and exhibits by which the respondent expects to establish its case, and each witness's testimony shall include a summary not to exceed one page. If not filed electronically, an original and fifteen (15) copies of such testimony and exhibits shall be submitted to the Clerk of the Commission. In all filings, the respondent shall

comply with the Commission's Rules of Practice, including 5 VAC 5-20-140, *Filing and service*, and 5 VAC 5-20-240, *Prepared testimony and exhibits*. All filings shall refer to Case No. PUR-2018-00167.

(12) The Staff shall investigate the Application. On or before February 22, 2019, the Staff shall file with the Clerk of the Commission an original and fifteen (15) copies of its testimony and exhibits, and each Staff witness's testimony shall include a summary not to exceed one page. The Staff shall serve a copy thereof on counsel to Dominion and all respondents.

(13) On or before March 7, 2019, Dominion shall file with the Clerk of the Commission: (a) any rebuttal testimony and exhibits that it expects to offer, and each rebuttal witness's testimony shall include a summary not to exceed one page; and (b) a summary not to exceed one page of each direct witness's testimony if not previously included therewith. The Company shall serve a copy of the testimony and exhibits on the Staff and all respondents. In addition to the service requirements of 5 VAC 5-20-260, on the day that copies are filed with the Clerk of the Commission, a copy of the interrogatory or request for production shall be served electronically, or by facsimile, on the party

to whom the interrogatory or request for production is directed or the assigned Staff attorney if the interrogatory or request for production is directed to the Staff.<sup>18</sup> Except as modified above, discovery shall be in accordance with Part IV of the Commission's Rules of Practice, 5 VAC 5-20-240 *et seq.*

(16) The Company's request for waiver of the requirements of 20 VAC 5-201-60 and 20 VAC 5-201-90 for filing Schedule 45 is granted as set forth in this Order.

(17) This matter is continued.
