Part I of the list includes companies with Medicare Supplement plans available to individuals age 65 or older. Part II of the list includes companies with Medicare Supplement plans available to individuals under age 65 and eligible for Medicare because of disability. The types of plans are indicated next to the corresponding company. All of the information provided is subject to change. Please note the date of revision at the top of each page.

Refer to the column entitled "Plans" to determine which of the Medicare Supplement standardized plans are currently marketed by a particular company. Other information to be considered is also noted in this column. The following may be helpful in assessing information that may be found in the "Plans" column:

- **High deductible Medicare Supplement Plans F and J.** These policies generally have higher deductibles and will cost you more "out-of-pocket" money before reimbursement may be made for certain services. The cost for these policies is generally lower than regular Medicare Supplement policies because of the high deductible feature.
- **Medicare Select plans.** These policies are generally less expensive than regular Medicare Supplement plans, but you must receive most medical care from providers who have contracted with the Medicare Select issuer.
