INSTRUCTIONS TO FORM LLC-1055

This amended application, which has been prescribed by the Commission, must be used by a foreign limited liability company that needs to amend or correct its application for a certificate of registration to transact business in Virginia, subject to the exceptions set forth in the second paragraph of the Notes, below.

The amended application must be in the English language, typewritten or printed in black, legible and reproducible, and presented on uniformly white, opaque paper, free of visible watermarks and background logos.

This form can be downloaded from our website in PDF-fillable format at www.scc.virginia.gov/clk/for_llc.aspx.

<u>IMPORTANT</u>: The amended application must be submitted with a **certified or otherwise authenticated copy** of any instrument of amendment, correction or merger filed by the limited liability company in its state or other jurisdiction of formation that effected the change(s) in said jurisdiction, **authenticated** <u>within the past 12 months</u> under the original signature and seal of the Secretary of State or official having custody of limited liability company records in the state or other jurisdiction of its formation. The certificate of the Secretary of State or other public official having custody of limited liability company records must indicate that each document is a "**true and correct copy**" of the official records, or words to that effect. See § 13.1-1055 of the Code of Virginia.

If the limited liability company has changed its name and its present name is not distinguishable upon the records of the Commission, the company will need to adopt a **designated name** for use in Virginia that is distinguishable upon the records of the Commission. See § 13.1-1054 of the Code of Virginia. To check the availability of a company name, including a designated name, visit https://sccefile.scc.virginia.gov/NameAvailability or contact the Clerk's Office at (804) 371-9733 or toll-free in Virginia, 1-866-722-2551.

If the new name of the limited liability company does not contain the words <u>limited company</u> or <u>limited liability company</u>, or the abbreviation <u>L.C.</u>, <u>LC</u>, <u>L.L.C.</u> or <u>LLC</u>, it must adopt a designated name for use in Virginia that <u>adds</u> one of the foregoing to its name. See § 13.1-1054 of the Code of Virginia.

This form is to be used by a limited liability company that wants to **abandon a designated name** that it previously adopted for use in Virginia because its real name is now distinguishable on the Commission's records.

This amended application must be **signed** (i) by a manager or other person who has been delegated the right and power to manage the business and affairs of the limited liability company, or (ii) if no managers or such other persons have been selected, by any member of the limited liability company, or (iii) by a person who is authorized to sign an amendment to the articles of organization or other constituent documents delivered for filing to the Secretary of State or other official having custody of limited liability company records in the state or other jurisdiction under whose law it is formed.

The printed name and title of the person who signs the amended application must be set forth next to the signature. An individual signing on behalf of a business entity that is (i) a manager or member of the limited liability company, or (ii) authorized to sign post-formation documents on behalf of the limited liability company, must set forth the business entity's name, the capacity in which the business entity is signing on behalf of the limited liability company, the individual's printed name, and the capacity in which he or she is signing on behalf of the business entity. See § 13.1-1003 of the Code of Virginia.

It is a Class 1 misdemeanor for any person to sign a document he or she knows is false in any material respect with intent that the document be delivered to the Commission for filing. See § 13.1-1006 of the Code of Virginia.

This amended application may not be filed with the Commission until all fees and penalties to be collected by the Commission under the Virginia Limited Liability Company Act have been paid by or on behalf of the limited liability company; provided, however, that an assessed annual registration fee does not have to be paid if this amended application is **filed** on or before the due date of the annual registration fee payment. See § 13.1-1065 of the Code of Virginia.

Submit the signed amended application <u>and</u> the original certified copy of the limited liability company's instrument effecting the amendment or change to State Corporation Commission, Office of the Clerk, P.O. Box 1197, Richmond, Virginia 23218-1197, (Street address: 1300 East Main Street, Tyler Building, 1st Floor, Richmond, Virginia 23219), along with a check for the filing fee in the amount of **\$25.00**, payable to State Corporation Commission. **DO NOT SEND CASH**. NOTES

Whenever the articles of organization or other constituent document of a foreign limited liability company that is registered to transact business in the Commonwealth is amended or corrected, the foreign limited liability company <u>must promptly file</u> with the Commission a copy of the amendment or correction duly authenticated by the Secretary of State or other official having custody of the limited liability company records in the state or other jurisdiction of its organization. See § 13.1-1055 of the Code of Va.

To change the company's **registered agent** and/or the **registered office address** in Virginia, or its **principal office address** on record with the Commission, in lieu of this form, the company must file a statement of change of registered agent/registered office on form LLC-1016, or a statement of change of principal office address on form LLC-1018.1. These forms can be completed and filed electronically through SCC eFile at https://sccefile.scc.virginia.gov.
