This is in reference to Central Telephone Company d/b/a CenturyLink's March 16, 2015 tariff filing submitted pursuant to the administrative process authorized by the Commission's November 13, 2014 order in Case No. PUC-2014-00034. The Division of Communications has determined that the competitive test criteria set out in this order have been met for residential BLETS individual line service in the Palmyra exchange. The Altavista, Buena Vista, Burnt Chimney, Lexington, Martinsville, Ridgeway, and Stanley exchanges also included in the filing were previously determined to meet the criteria.

Accordingly, Central Telephone has revised the tariff page included in the March 16, 2015 filing to reflect the inclusion of the Palmyra exchange discussed above. A stamped copy of the accepted tariff page is enclosed.
