

This is in reference to Central Telephone Company d/b/a CenturyLink's April 20, 2015 tariff filing submitted pursuant to the administrative process authorized by the Commission's November 13, 2014 order in Case No. PUC-2014-00034. The Division of Communications has determined that the competitive test criteria set out in this order have been met for residential BLETs individual line service in the Bassett, Boones Mill, Collinsville, Fieldale, Front Royal, Rocky Mount, South Boston and Spencer exchanges.

Additionally, Central Telephone revised the tariff page included in the April 20, 2015 filing to reflect revisions due to the intervening inclusion of the Palmyra exchange that was also found to have met the competitive test criteria. A stamped copy of the accepted tariff page is enclosed.
