This is in reference to Central Telephone Company d/b/a CenturyLink's July 2, 2015 tariff filing submitted pursuant to the administrative process authorized by the Commission's November 13, 2014 order in Case No. PUC-2014-00034. The Division of Communications has determined that the competitive test criteria set out in this order have been met for residential BLETS individual line service in the Axton, Bachelors Hall, Blackstone, Crozet, Farmville, LaCrosse, Luray, Natural Bridge, Rustburg, Shenandoah, South Hill, and Stanardsville exchanges.

On August 12, 2015, Central Telephone and the Staff agreed to extend the initial review period to September 30, 2015.
