On behalf of China Oceanwide, enclosed please find an original and fifteen (15) copies of an amended Exhibit 2(a) (Organizational Chart Prior to the Transaction) to the Application filed with the State Corporation Commission on December 8, 2016.

The changes to Exhibit 2(a) reflect the acquisition by China Oceanwide, through its majority owned indirect subsidiaries, Zhihai Capital Investment Management Co., Ltd. ("Zhihai") and Oriental Rainbow LLC, of International Data Group Inc. ("IDG"), a Massachusetts corporation, on March 29, 2017. As a result of this acquisition, China Oceanwide became the controlling shareholder of IDG, with a 90% ownership interest. The remaining 10% ownership interest is held by Beijing Harmony Tianming Investment Center (Limited Partnership), an entity unaffiliated with China Oceanwide that is the minority shareholder of Zhihai.

- pages 8 through 13 were added to the organizational chart to reflect the newly acquired IDG entities.

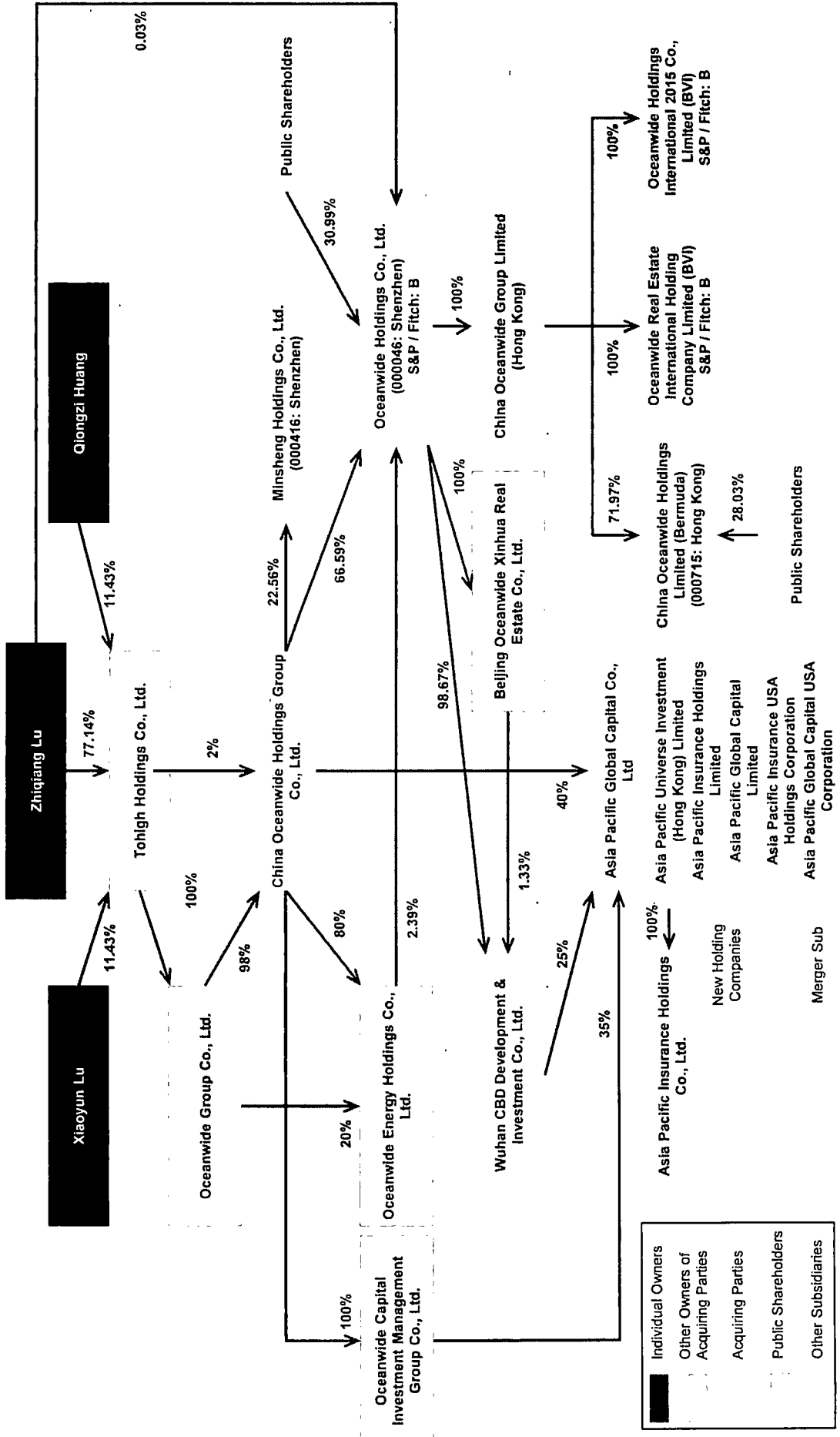

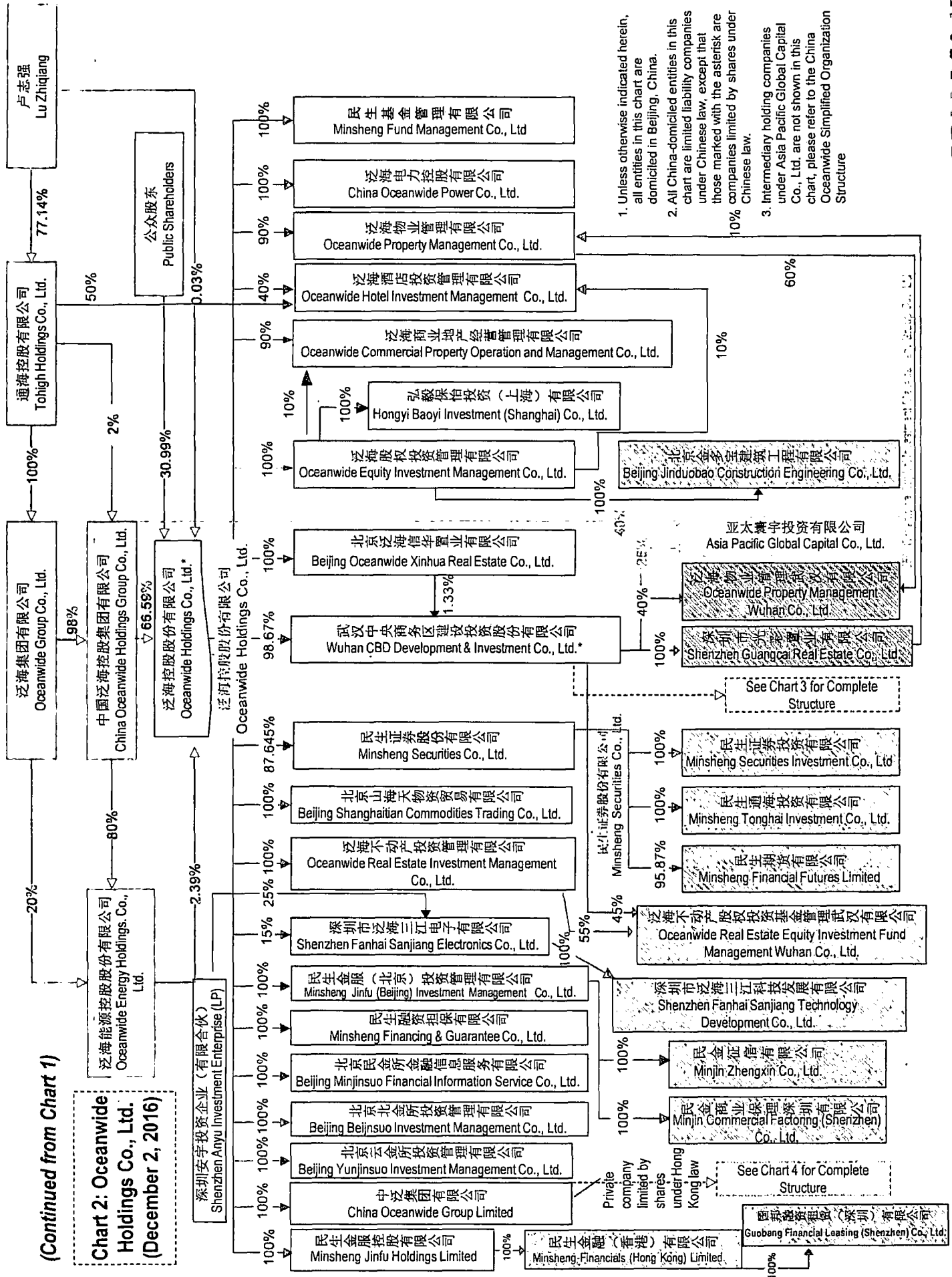
CHINA OCEANWIDE SIMPLIFIED ORGANIZATION STRUCTURE

 2. The New Holding Companies and Merger Sub are only shown in this simplified organization structure.

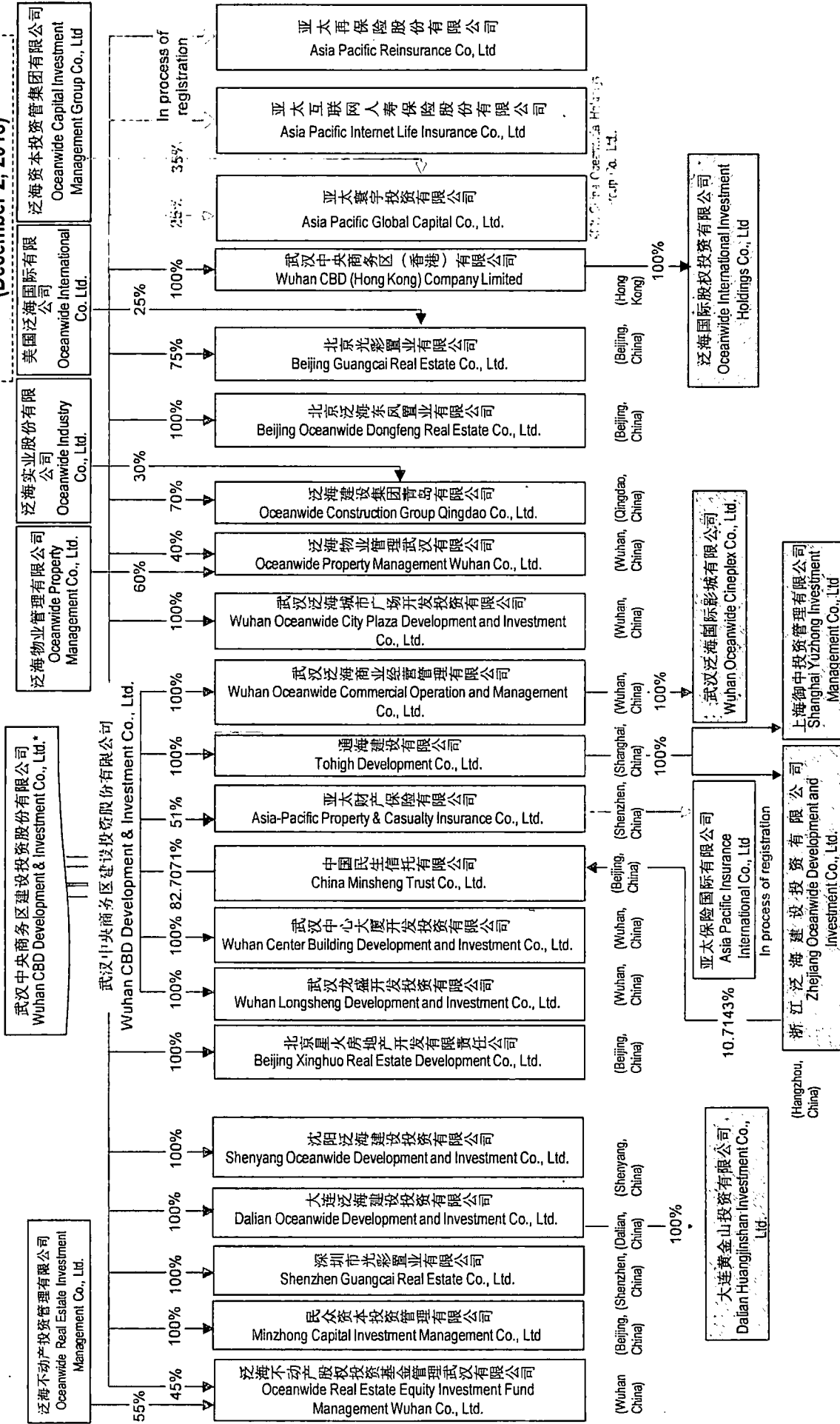

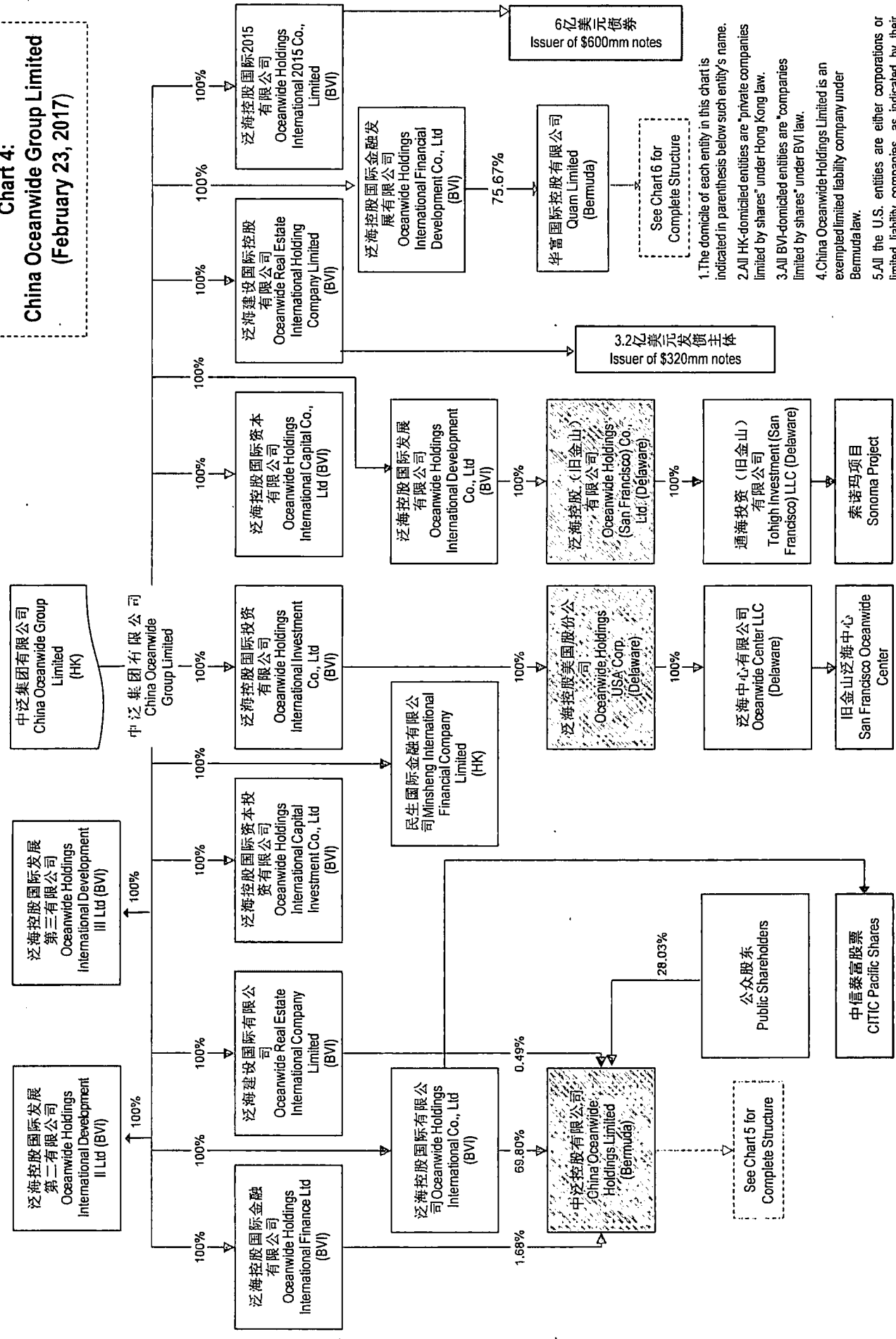
Chart 3: Wuhan CBD Development & Investment Co., Ltd. (December 2, 2016)

(February 23, 2017)**

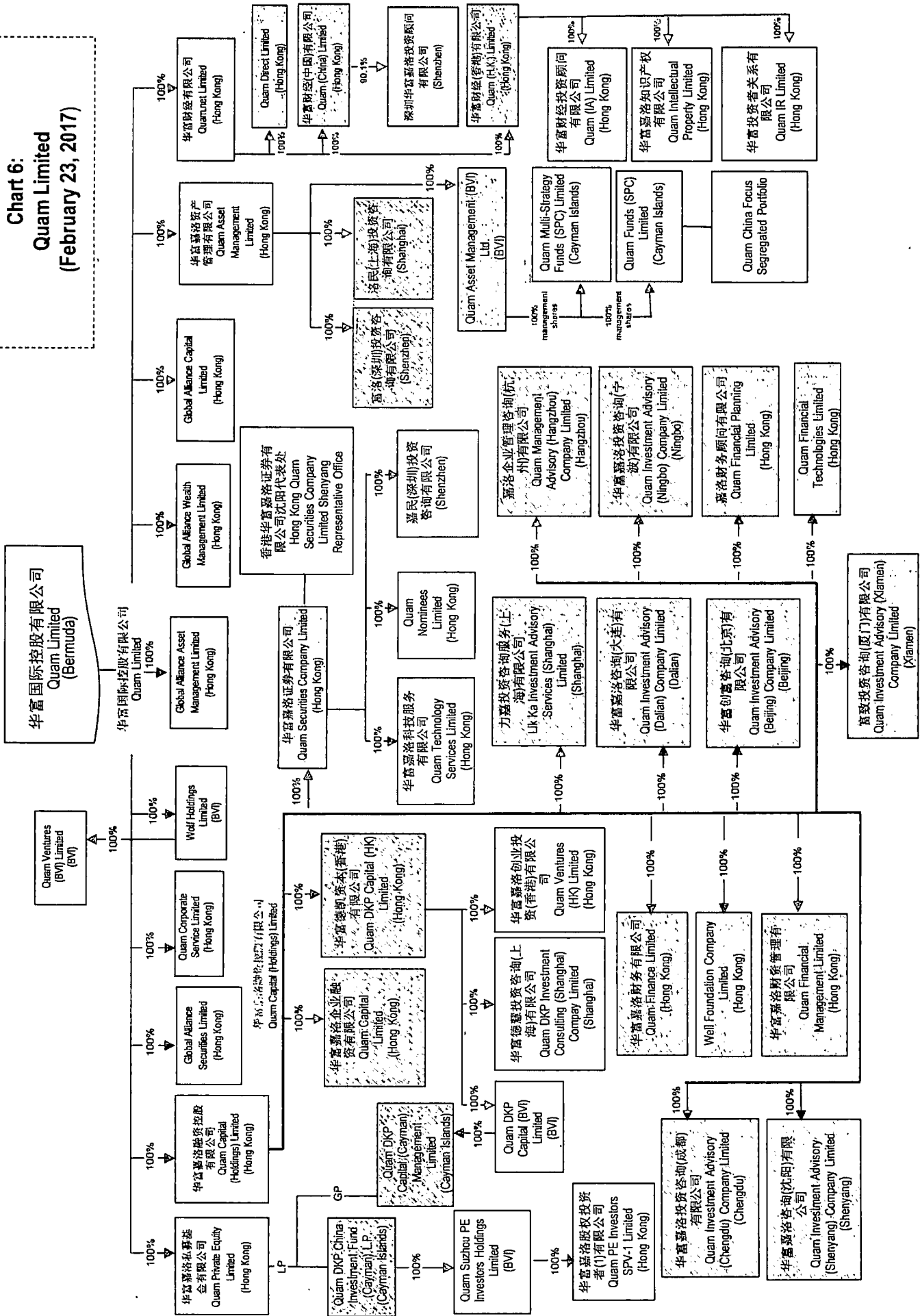

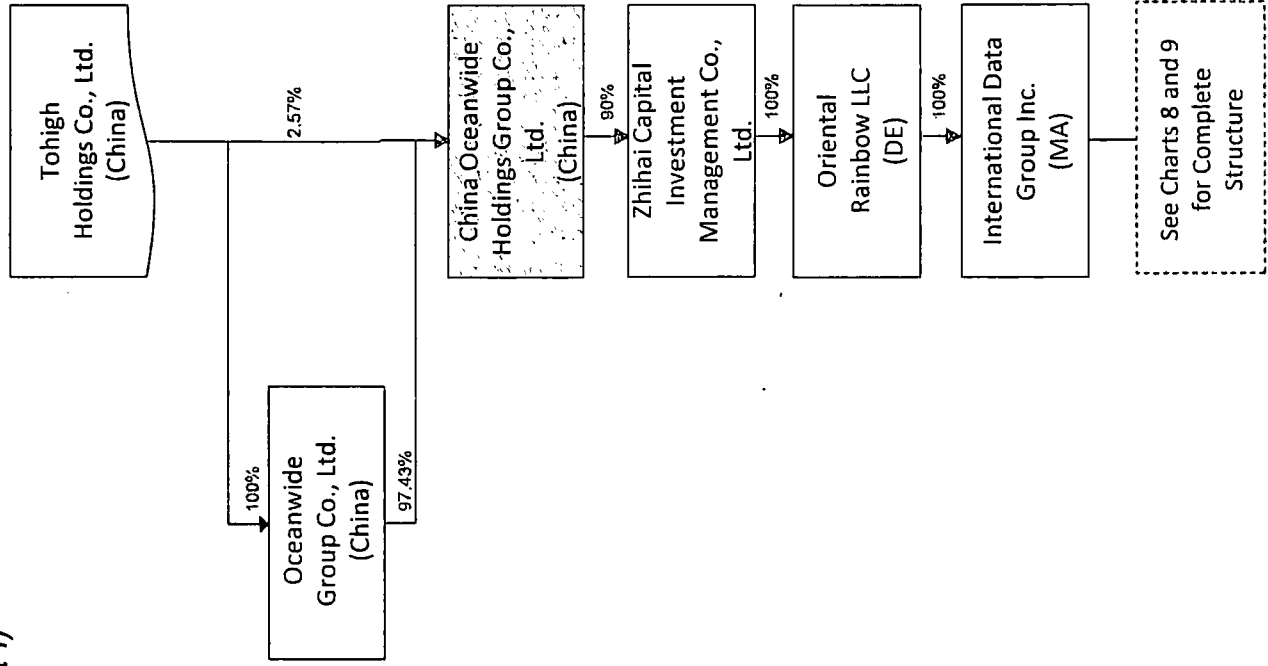
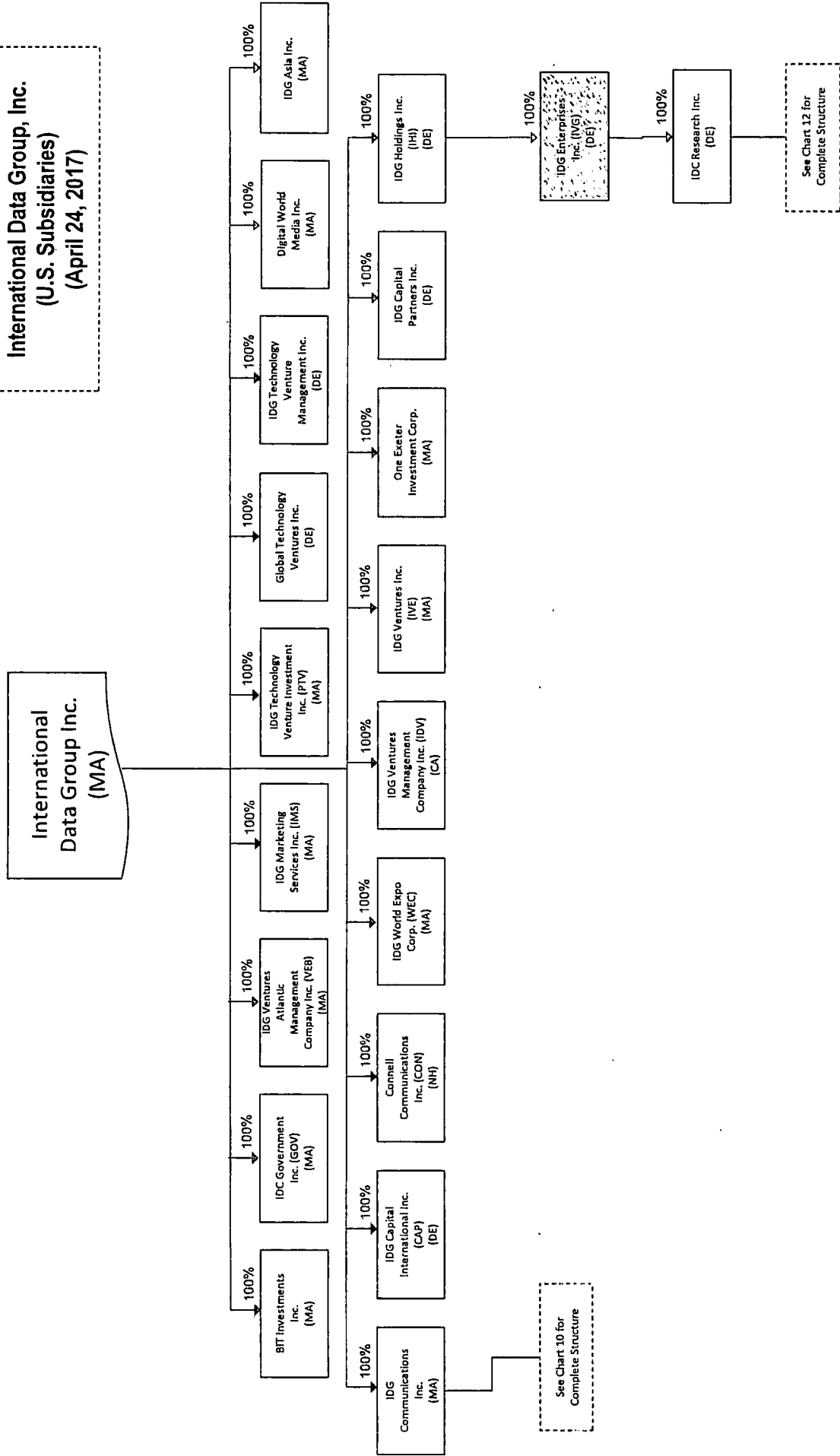


Chart 7:

(April 24, 2017)

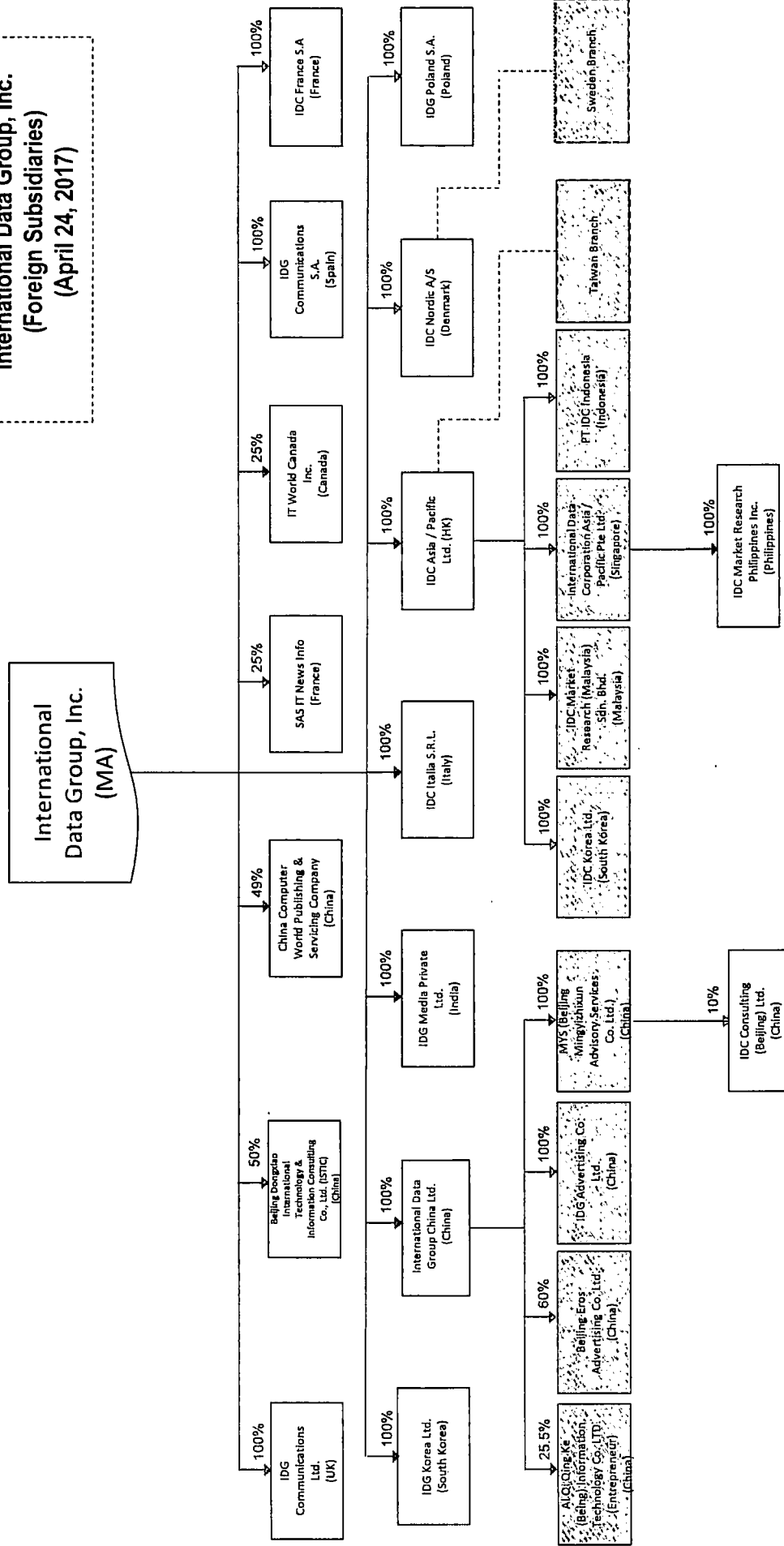

(April 24, 2017)



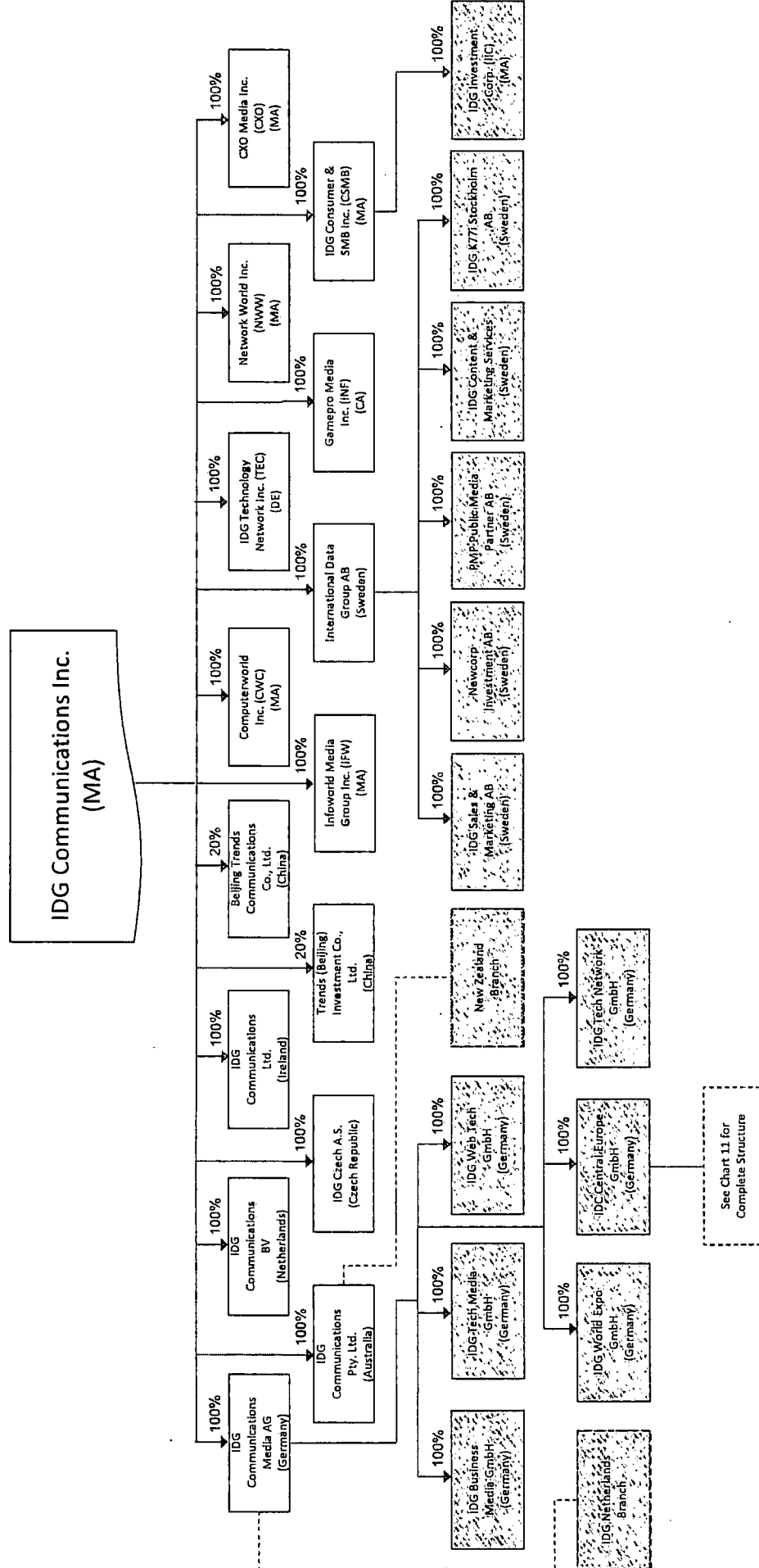

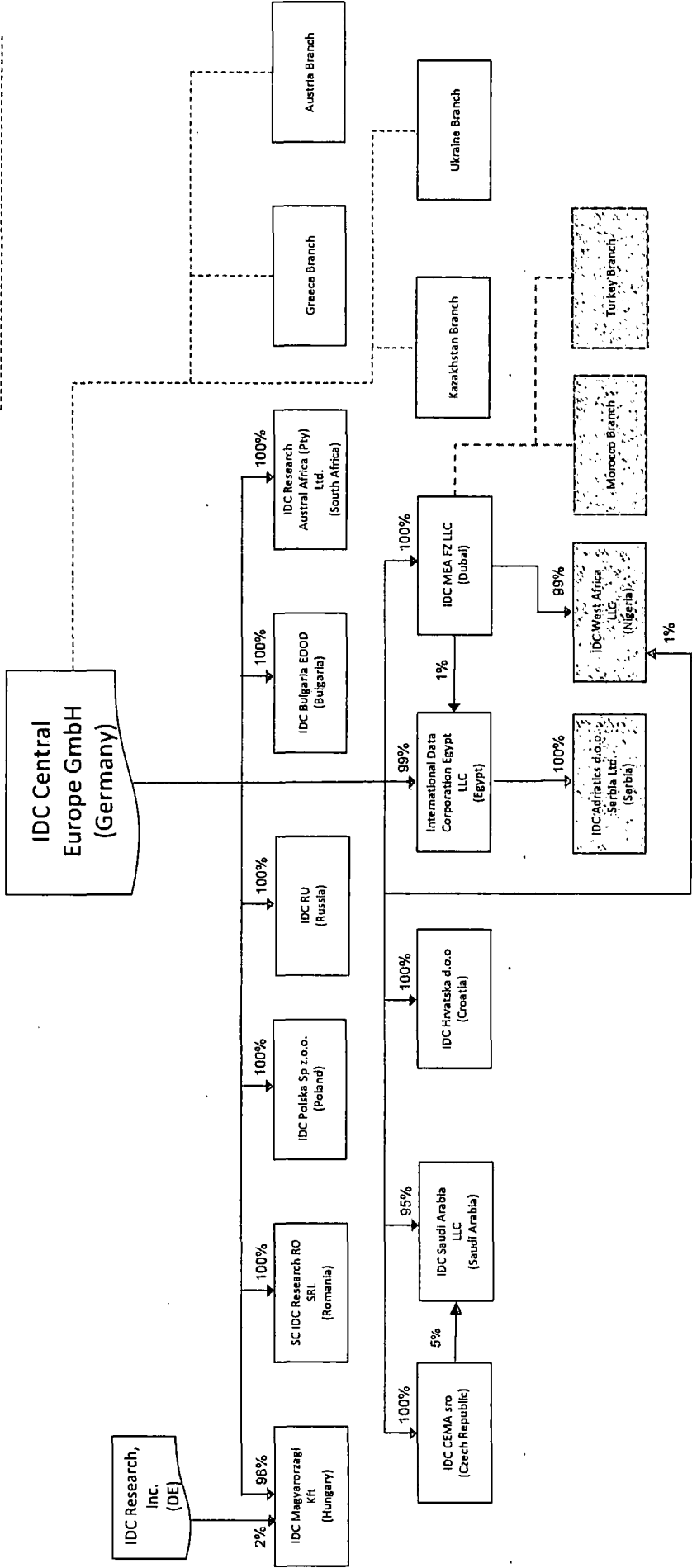

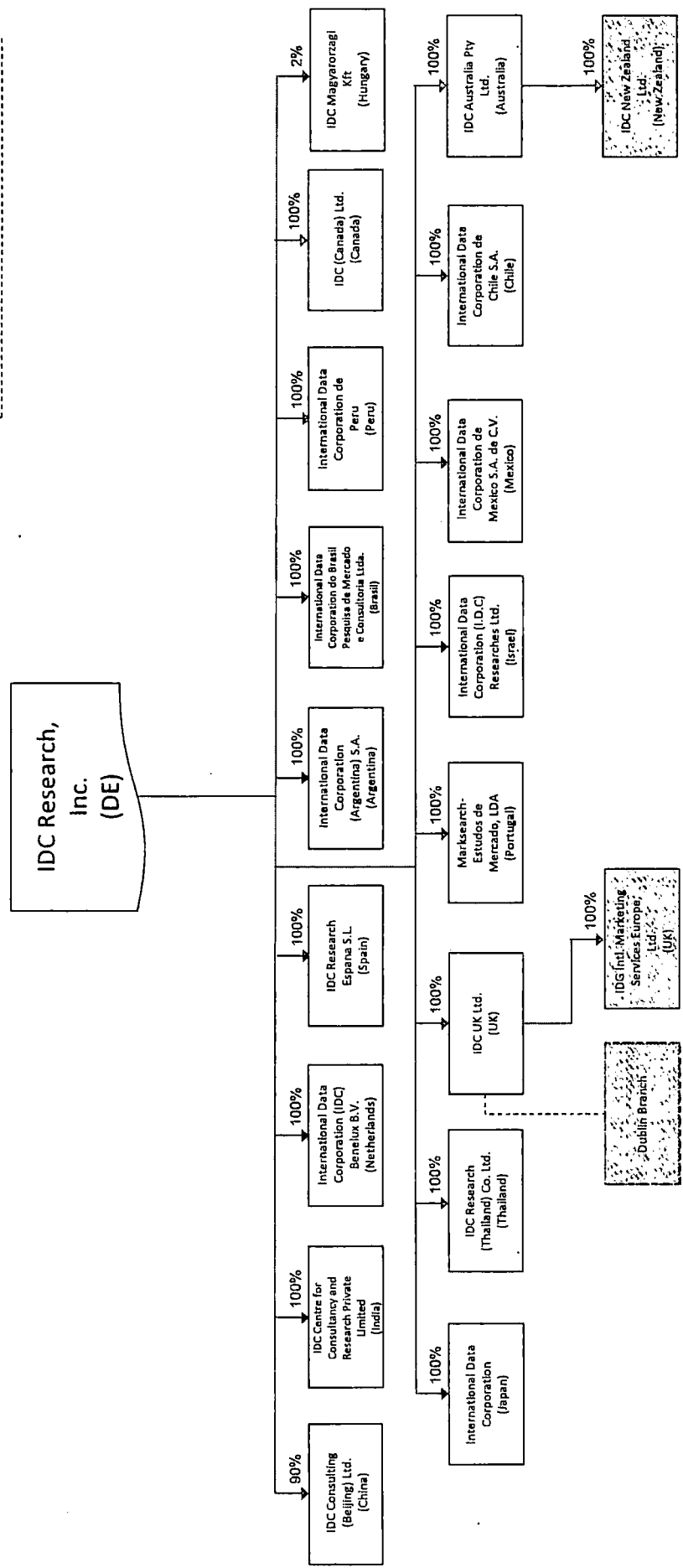
