*Ex Parte: Electrification of Motor Vehicles*ORDER SCHEDULING PUBLIC SESSION

On March 24, 2020, the State Corporation Commission ("Commission") issued its Order Establishing Proceeding Regarding Electric Vehicles ("Order"), recognizing that the increased deployment of motor vehicles (automobiles, trucks and buses) powered by electricity ("electric vehicles" or "EVs") presents several issues that potentially could affect the affordability and reliability of electricity service delivered to consumers by regulated utilities.

To receive input from interested persons and entities, the Commission (1) permitted the filing of written or electronic comments on or before June 23, 2020, and (2) scheduled a public session to be convened on July 8, 2020, in the Commission's second floor courtroom, Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, to receive comments regarding the issues under consideration in this matter.

NOW THE COMMISSION, upon consideration of the ongoing public health emergency related to the spread of the coronavirus, or COVID-19, is of the opinion and orders that the previously scheduled public session shall be convened as set forth below:

- (1) On July 8, 2020, commencing at 10 a.m., the Commission will convene a telephonic public session in this matter. To promote fairness for all participants, each person or entity will be allotted five minutes to provide comments.
- (2) On or before 5 p.m. on July 6, 2020, any person desiring to offer comments at this public session shall provide the Commission (a) your name, and (b) the telephone number that you wish the Commission to call during the hearing to receive your testimony. This information may be provided to the Commission in three ways:
 - (i) by filling out a form on the Commission's website at

<https://scc.virginia.gov/pages/Webcasting>; (ii) by completing and emailing the PDF version of this form to SCCInfo@scc.virginia.gov; or (iii) by calling 804-371-9141 during normal business hours.

- (3) Beginning at 10 a.m. on July 8, 2020, the Commission will telephone sequentially each person that has signed up to comment as provided above.
- (4) This public session will be webcast at <https://scc.virginia.gov/pages/Webcasting>.
- (5) Persons and entities that previously filed written comments in this docket are not required to appear in order for those comments to become part of the record in this matter; however, those persons and entities may participate in the public session to provide a summary of their written comments, to add any further comments they may have, and to answer any questions the Commissioners may have regarding those comments.

Accordingly, IT IS SO ORDERED, and this matter is CONTINUED.
