ADMINISTRATIVE ORDER NO. 8124

ORDER SUSPENDING THE REQUIREMENT OF FILING CERTAIN FORMS AND ENDORSEMENTS FOR WRITING GENERAL LIABILITY, COMMERCIAL CRIME, COMMERCIAL GLASS, COMMERCIAL MULTI-PERIL (EXCLUDING AUTOMOBILE), BOILER AND MACHINERY, COMMERCIAL INLAND MARINE, COMMERCIAL FARM, AND COMMERCIAL FIRE UNDER THE PROVISIONS OF § 38.1-279.32 [RECODIFIED AS § 38.2-317 F] OF THE CODE OF VIRGINIA.

WHEREAS, IT APPEARING to the Commission that the requirement of filing certain forms and endorsements for the lines of insurance captioned above should be suspended, pursuant to the provisions of § 38.1-279.32 [recodified as § 38.2-317 F] of the Code of Virginia, when such form(s) and endorsement(s) (commonly referred to as "manuscript forms") are utilized on an individual risk basis to broaden the coverage contained in the basic contract to which the form(s) and endorsement(s) are to be attached because such forms, when used on an individual risk basis, cannot practicably be filed before they are utilized.

IT IS, THEREFORE, ORDERED:

(1) That the requirement of filing certain forms and endorsements for the lines of insurance hereinabove captioned, when such form(s) and endorsement(s) (commonly referred to as "manuscript forms") are utilized on an individual risk basis to broaden the coverage contained in the basic contract to which the form(s) and endorsement(s) are to be attached be, and they hereby are, suspended under the provisions of § 38.1-279.32 [recodified as § 38.2-317 F]. by entry of this Order, until the further Order

of the Commission, for the reason that such form(s) and endorsement(s) cannot practicably be filed before they are utilized on an individual risk basis; and (2) That the form(s) and endorsement(s) affected by this Order and hereinafter used by insurers shall not be misleading or against public policy. The Commission hereby reserves the right, either upon its own motion, or upon complaint, to make such examination or investigation with respect thereto as it may deem advisable or necessary in order to determine whether any form or endorsement affected by such suspension may be, or may become, misleading or against public policy.

IT IS, FURTHER, ORDERED, That an attested copy hereof shall be sent to every rate service organization licensed in this Commonwealth, the Bureau of Insurance, and to all insurance companies licensed to write property and casualty insurance in this Commonwealth.
