ORDER FOR NOTICE AND COMMENT

On August 18, 2020, Resource Energy Solutions, LLC ("Resource" or "Company"), filed an application with the State Corporation Commission ("Commission") for a license to conduct business as an aggregator of electricity and natural gas services ("Application"). Resource seeks authority to provide electric and natural gas aggregation services throughout Virginia to eligible commercial and industrial customers. In its Application, Resource attested that it would abide by all applicable regulations of the Commission as required by 20 VAC 5-312-40 B of the Commission's Rules Governing Retail Access to Competitive Energy Services.

NOW THE COMMISSION, upon consideration of the Application, is of the opinion and finds that it should docket Resource's Application; Resource should serve this Order upon the

appropriate persons; the Commission's Staff ("Staff") should conduct an investigation of the Application and present its findings in a report ("Staff Report"); and interested persons should have an opportunity to comment on the Application. We further find that a Hearing Examiner should be appointed to rule on all discovery matters that arise during the course of this proceeding.

Accordingly, IT IS ORDERED THAT:

- (1) This matter is docketed and assigned Case No. PUR-2020-00159.
- (2) As provided by Code § 12.1-31 and 5 VAC 5-20-120, *Procedure before hearing examiners*, of the Commission's Rules of Practice and Procedure ("Rules of Practice"),⁴ a Hearing Examiner is appointed to rule on any discovery issues that may arise during the course of this proceeding.
- (3) A copy of the Application may be viewed or downloaded from the Commission's website: scc.virginia.gov/pages/Case-Information.
- (4) On or before October 14, 2020, Resource shall serve a copy of this Order upon the utilities listed on Attachment A to this Order.⁵
- (5) In accordance with the Commission's revised operating procedures during the COVID-19 emergency, all comments, pleadings, and documents shall be submitted electronically to the Clerk of the Commission to the extent authorized by the Commission's Rules of Practice.⁶

- (6) On or before October 21, 2020, the Company shall file proof of service as ordered herein with the Clerk of the State Corporation Commission, c/o Document Control Center, P.O. Box 2118, Richmond, Virginia 23218-2118, or by filing electronically at scc.virginia.gov/clk/efiling/.
- (7) Any interested person may request a public copy of the Application, accompanying materials, and this Order by directing a request in writing to Richard Plutzer, Executive Vice President, Resource Energy Solutions, LLC, 4 High Ridge Park, Suite 202, Stamford, CT 06905, replutzer@resourceenergy.com. The Company shall, within three (3) days of receipt of such request, serve the requested documents upon the person making such request.
- (8) Comments on the Application may be filed on or before October 28, 2020, with the Clerk of the Commission at: scc.virginia.gov/casecomments/Submit-Public-Comments or at the mailing address in Ordering Paragraph (6). A copy of such comments, whether submitted in writing or electronically, shall be served upon the Company at the email address set forth in Ordering Paragraph (7). Such comments simultaneously shall be sent electronically to Richard Michaux, Senior Utility Accountant, at Richard.Michaux@scc.virginia.gov. All comments shall refer to Case No. PUR-2020-00159.
- (9) The Staff shall analyze Resource's Application and shall present its findings in a Staff Report to be filed on or before November 5, 2020.

- (11) All documents filed in paper form with the Office of the Clerk of the Commission in this docket may use both sides of the paper. In all other respects, all filings shall comply fully with the requirements of 5 VAC 5-20-150, *Copies and format*, of the Commission's Rules of Practice.
- (12) The Company shall respond to written interrogatories or data requests within five (5) calendar days after the receipt of the same. Interrogatories and data requests, as well as the responses thereto, shall be transmitted via facsimile or electronic mail as well as by first class mail. Except as modified herein, discovery shall be in accordance with Part IV of the Commission's Rules of Practice.
