CERTIFICATE OF A CONTROL PERSON OF A TRUST COMPANY PURSUANT TO § 6.2-1024 OF THE CODE OF VIRGINIA

§ 6.2-1024 A of the Code of Virginia prohibits generally persons who are agents, broker-dealers, investment advisors, or investment advisor representatives (as defined in § 13.1-501 of the Code of Virginia) or investment companies (15 U.S.C. Section 80a-3) from acquiring control of a trust company, <u>i.e.</u>, the owner of twenty-five percent or more of voting stock of the trust company.

The purpose of this certificate is to establish an individual's eligibility to control a trust company. Individuals who fail to complete the certificate will be presumed ineligible.
