### ORDER FOR NOTICE AND HEARING

On July 1, 2020, Virginia Electric and Power Company d/b/a Dominion Energy Virginia ("Dominion" or "Company"), pursuant to § 56-585.1 A 6 of the Code of Virginia ("Code"), filed with the State Corporation Commission ("Commission") an annual update of the Company's rate adjustment clause, Rider US-3 ("Application"). Through its Application, the Company seeks to recover costs associated with two utility scale solar photovoltaic generating facilities: (i) the Colonial Trail West Solar Facility, an approximately 142 megawatt ("MW") (nominal alternating current ("AC")) facility located in Surry County; and (ii) the Spring Grove 1 Solar Facility, an approximately 98 MW AC facility located in Surry County (collectively, "US-3 Solar Projects" or "Projects"). Dominion also filed a Motion for Entry of a Protective Ruling ("Motion for Protective Ruling"), as well as a proposed Protective Ruling with its Application.

On January 24, 2019, and April 15, 2019, respectively, the Commission approved

Dominion's construction and operation of the US-3 Solar Projects and also approved a rate

adjustment clause, designated Rider US-3, for the Company to recover costs associated with the

Application at 1.

construction of the Projects.<sup>2</sup> On March 20, 2020, the Commission approved the first annual update to Rider US-3 and directed the Company to file its next Rider US-3 annual update on or after July 1, 2020.<sup>3</sup>

In this proceeding, Dominion has asked the Commission to approve Rider US-3 for the rate year beginning June 1, 2021, and ending May 31, 2022 ("2021 Rate Year").<sup>4</sup> The two key components of the proposed total revenue requirement for the 2021 Rate Year are the Projected Cost Recovery Factor and the Actual Cost True-Up Factor.<sup>5</sup> The Company is requesting recovery of a Projected Cost Recovery Factor revenue requirement of approximately \$33,154,062 and an Actual Cost True-Up Factor revenue requirement of \$5,545,991, resulting in a 2021 Rate Year total revenue requirement of \$38,700,053.<sup>6</sup> The Company is utilizing a rate of return on common equity of 9.2% in this proceeding consistent with the Commission's Final Order in Case No. PUR-2019-00050.<sup>7</sup>

If the proposed Rider US-3 for the 2021 Rate Year is approved, the impact on customer bills would depend on the customer's rate schedule and usage. According to Dominion, implementation of its proposed Rider US-3 on June 1, 2021, would increase the bill of a residential customer using 1,000 kilowatt hours per month by approximately \$0.16.8

Dominion requests that the Commission waive, in part, the requirements under Rules 20 VAC 5-201-60 ("Rule 60") and 20 VAC 5-201-90 ("Rule 90") of the Rules Governing Utility Rate Applications and Annual Informational Filings<sup>9</sup> with respect to Schedule 45.<sup>10</sup> Rule 60 requires that an application filed pursuant to Code § 56-585.1 A 6 include Schedule 45, "Return on Equity Peer Group Benchmark," with the utility's direct testimony. Rule 90 states that Schedule 45 must include "documentation supporting the return on equity benchmark proposed pursuant to § 56-585.1 A 2 a and b of the Code . . . . " In support of its request for waiver of Schedule 45, Dominion states that pursuant to the provisions of Code §§ 56-585.1 and 56-585.1:1, and consistent with recent Commission orders granting similar limited waivers, <sup>11</sup> a return on equity determination is not to be made in this proceeding. <sup>12</sup>

Dominion also requests that the Commission waive, in part, the requirements under Rule 60 and Rule 90 with respect to paper copies of certain Schedule 46 materials.<sup>13</sup> Rule 60

requires that an application filed pursuant to Code § 56-585.1 A 6 include Schedule 46,
"Projected Rate Adjustment Clause Pursuant to § 56-585.1 A 4, A 5 b, c and d or A 6 of the
Code of Virginia," with the utility's direct testimony. Rule 90 states that the Company must
"provide all documents, contracts, studies, investigations or correspondence that support
projected costs proposed to be recovered via a rate adjustment clause." According to Dominion,
the supporting documentation responsive to this request is voluminous and therefore the
Company proposes to provide the documentation in electronic format only.<sup>14</sup>

Dominion further requests a waiver, in part, of the Rule 60 and Rule 90 requirements with respect to the portions of Filing Schedule 46 related to approval of the US-3 Solar Projects as required by public convenience and necessity. Specifically, the Company requests a continuous and ongoing waiver of the portions of Schedule 46 related to approval of the US-3 Solar Projects as required by the public convenience and necessity ("CPCN-related information"). In support of its request for waiver, the Company asserts that such CPCN-related information does not directly pertain to the relief requested in this 2020 Annual Update and, further, such information has already been provided, or findings related to these topics have already been made by the Commission in Case No. PUR-2018-00101.

Finally, in conjunction with the filing of its Application on July 1, 2020, the Company filed a Motion for Protective Ruling and a proposed Protective Ruling that establishes procedures governing the use of confidential information in this proceeding.

NOW THE COMMISSION, upon consideration of this matter, is of the opinion and finds that this matter should be docketed; Dominion should provide public notice of its Application; a public hearing should be scheduled for the purpose of receiving testimony and evidence on the Application; interested persons should have an opportunity to file comments on the Application or participate as a respondent in this proceeding; and the Staff of the Commission ("Staff") should be directed to investigate the Application and file testimony and exhibits containing its findings and recommendations thereon. We further find that a Hearing Examiner should be assigned to conduct all further proceedings in this matter on behalf of the Commission, including filing a final report containing the Hearing Examiner's findings and recommendations.

We grant Dominion's request to waive, in part, Schedule 45 and Schedule 46 requirements for purposes of commencing this proceeding. We also grant the Company's request for a limited, ongoing partial waiver of Schedule 46 requirements regarding CPCN-related information, which has previously been filed and reviewed as part of Case No. PUR-2018-00101. By granting this limited waiver, the Commission is not ruling on the relevance, if any, that CPCN-related information required by Schedule 46 may have in this proceeding or any future Rider US-3 proceedings. <sup>18</sup>

The Commission further takes judicial notice of the ongoing public health emergency related to the spread of the coronavirus, or COVID-19, and the declarations of emergency issued

at both the state and federal levels.<sup>19</sup> The Commission has taken certain actions, and may take additional actions going forward, that could impact the procedures in this proceeding.<sup>20</sup> Consistent with these actions, in regard to the terms of the procedural framework established below, the Commission will, among other things, direct the electronic filing of testimony and pleadings unless they contain confidential information and will require electronic service on parties to this proceeding.

For clarification, we note that the proposed Rider US-3, if approved, would result in an increase to customer bills. We realize that the current COVID-19 public health crisis has caused devastating economic effects that impact all utility customers. We have responded to this economic emergency by, among other actions, temporarily suspending customer service disconnections for customers of Virginia utilities during the pandemic emergency.<sup>21</sup> We are

sensitive to the effects of rate increases, especially in times such as these. The Commission, however, must and will follow the laws applicable to this case, as well as the findings of fact supported by evidence in the record.

# Accordingly, IT IS ORDERED THAT:

- (1) This matter is docketed and assigned Case No. PUR-2020-00122.
- (2) As provided by Code § 12.1-31 and 5 VAC 5-20-120, *Procedure before hearing examiners*, of the Commission's Rules of Practice and Procedure ("Rules of Practice"), <sup>22</sup> a Hearing Examiner is appointed to conduct all further proceedings in this matter on behalf of the Commission, including ruling on the Company's Motion for Protective Ruling.
- (3) All pleadings in this matter should be submitted electronically to the extent authorized by Rule 5 VAC 5-20-150, *Copies and format*, of the Commission's Rules of Practice. Confidential and Extraordinarily Sensitive information shall not be submitted electronically and should comply with 5 VAC 5-20-170, *Confidential information*, of the Rules of Practice. For the duration of the COVID-19 emergency, any person seeking to hand deliver and physically file or submit any pleading or other document shall contact the Clerk's Office Document Control Center at (804) 371-9838 to arrange the delivery.<sup>23</sup>
- (4) Pursuant to 5 VAC 5-20-140, *Filing and service*, of the Commission's Rules of Practice, the Commission directs that service on parties and the Staff in this matter shall be accomplished by electronic means. Concerning Confidential or Extraordinarily Sensitive

Information, parties and the Staff are instructed to work together to agree upon the manner in which documents containing such information shall be served upon one another, to the extent practicable, in an electronically protected manner, even if such information is unable to be filed in the Office of the Clerk, so that no party or the Staff is impeded from preparing its case.

Pursuant to 5 VAC 5-20-80 B, *Participation as a respondent*, of the Commission's Rules of Practice, any notice of participation shall set forth: (i) a precise statement of the interest of the respondent; (ii) a statement of the specific action sought to the extent then known; and (iii) the factual and legal basis for the action. Any organization, corporation, or government body

participating as a respondent must be represented by counsel as required by 5 VAC 5-20-30, *Counsel*, of the Rules of Practice. All filings shall refer to Case No. PUR-2020-00122.

- (13) Within five (5) business days of receipt of a notice of participation as a respondent, the Company shall serve upon each respondent a copy of this Order for Notice and Hearing, a copy of the public version of the Application, and a copy of the public version of all materials filed by the Company with the Commission, unless these materials already have been provided to the respondent.
- (14) On or before October 27, 2020, each respondent may file with the Clerk of the Commission and serve on the Staff, the Company, and all other respondents, any testimony and exhibits by which the respondent expects to establish its case, and each witness's testimony shall include a summary not to exceed one page. In all filings, respondents shall comply with the Commission's Rules of Practice, as modified herein, including, but not limited to: 5 VAC 5-20-140, *Filing and service*, and 5 VAC 5-20-240, *Prepared testimony and exhibits*. All filings shall refer to Case No. PUR-2020-00122.
- (15) On or before November 19, 2020, the Staff shall investigate the Application and file with the Clerk of the Commission its testimony and exhibits concerning the Application, and each Staff witness's testimony shall include a summary not to exceed one page. A copy thereof shall be served on counsel to the Company and all respondents.
- (16) On or before December 7, 2020, Dominion shall file with the Clerk of the Commission any rebuttal testimony and exhibits that it expects to offer, and each rebuttal witness's testimony shall include a summary not to exceed one page. The Company shall serve a copy of its rebuttal testimony and exhibits on the Staff and all respondents.

- (17) Any documents filed in paper form with the Office of the Clerk of the Commission in this docket may use both sides of the paper. In all other respects, all filings shall comply fully with the requirements of 5 VAC 5-20-150, *Copies and format*, of the Commission's Rules of Practice.
- (18) The Commission's Rule of Practice 5 VAC 5-20-260, *Interrogatories or requests* for production of documents and things, shall be modified for this proceeding as follows: responses and objections to written interrogatories and requests for production of documents shall be served within seven (7) calendar days after receipt of the same. In addition to the service requirements of 5 VAC 5-20-260 of the Rules of Practice, on the day that copies are filed with the Clerk of the Commission, a copy of the interrogatory or request for production shall be served electronically on the party to whom the interrogatory or request for production is directed or the assigned Staff attorney, if the interrogatory or request for production is directed to the Staff.<sup>25</sup> Except as modified herein, discovery shall be in accordance with Part IV of the Commission's Rules of Practice, 5 VAC 5-20-240 et seq.
