

# File a Registered Agent Resignation for a Virginia Business Entity in the Clerk's Information System

Every Virginia and foreign business entity authorized to transact business in Virginia must continuously maintain a Virginia-located registered agent and registered office. This how-to guide will walk you through filing a Statement of Resignation of Registered Agent online in the new Clerk's Information System (CIS) <https://cis.scc.virginia.gov/>.

1 Log on to CIS at <https://cis.scc.virginia.gov/>.  
*Note: Google Chrome, Internet Explorer or Microsoft Edge are recommended.*

2 Click **Online Services** on the top left.

3 Under Business Entities, click **Existing Businesses**.

4 Select the **Virginia Entity** button. Select the appropriate **Business Entity Type** from the drop-down.




5 Select **Statement of Resignation of Registered Agent** from the filing type drop-down and click **Continue**.

6 Locate your business in the system by either:  
 A. Searching for it using the **Entity Name** field, OR  
 B. Entering your **Entity ID**.

7 Click **Search**.

8 Click the **Select** button next to your business' name. **DO NOT** click the green entity name.

9 Click **Continue**.

- 10 Once the Entity Information appears, click **Next**.
- 11 Review the Registered Agent Information sections. If applicable, check the **Registered Office is to be discontinued** box.
- 12 Click **Next**.
- 13 Indicate if you are signing as an **Individual** or **On Behalf of Business Entity** by checking the appropriate radio button.
- 14 Complete all fields with an asterisk (\*) in the **Signature Information** section.
- 15 Click **Add**.
- 16 Click **OK** in the pop-up box.
- 17 The signature information will populate. Check the box beside the affirmation statement and click **Next**.
